

MARYLAND SHIPPING CARRIER RETURN INSTRUCTIONS

This document provides the process for returning all scorable and nonscorable paper-based test materials to Pearson. Follow the instructions in the Test Coordinator Manual for shipping paper-based materials to Pearson. **A pickup of paper-based test materials must be scheduled and completed no later than 5 business days after testing is complete.**

Note:

- There will be one freight Bill of Lading for scorable and nonscorable test materials in the Test Coordinator Kit. No account number is needed.
- **Only one school may be packed into a box to ensure all materials are accounted for correctly. Multiple grades and subjects for that school are allowed in a box.**
- LSS/LEA 24's that receive overage test materials will have additional Pearson colored return labels in the LAC Test Coordinator Kit to use if additional school labels are needed.
- Generic return labels include blank fields where pertinent state, LSS/LEA 24, and school information must be recorded prior to return to Pearson.

RETURNING SCORABLE SECURE MATERIALS

Once materials are ready to ship, the Test Coordinator will apply one Pearson colored label to each scorable box being returned. Scorable label color is:

- ELA/Math - **RED**
- Science - **YELLOW**
- Social Studies - **OLIVE**

Non Scorable Materials to Return

- Unused test books (including for absent students)
- Unused answer documents (grades 4–high school ELA/L and mathematics only)
- Used test books and answer documents that have been marked “Do Not Score”
- Human Reader scripts
- Large Print test books
- Braille test books
