Purpose

The purpose of this document is to provide the information needed when uploading students to LaunchPad. This guide is only for the purpose of creating students via the import process.

Steps to Uploading Students

In LaunchPad menu > Data Import > Single File Upload

- Click Upload File > Student (Confirm School Year is accurate)
- Fill in details for the student including demographics.

Once the file is filled out then:

- Save as CSV
- Upload File
