

### 4.8.3 Return Materials to STC

The following are materials that must be returned to the STC:

- Student Print Cards and Seal Codes (secure documents)
- Mathematics reference sheets, calculators, and Mathematics tools for administration (if applicable)
- Accommodated test materials (inform the STC of any tests needing transcription)
- Used and unused scratch paper
- Mathematics Human Reader Scripts (secure documents) if applicable

## 4.9 Make-Up Testing

If a student starts a Section and leaves the testing environment (e.g., due to illness, family emergency) without finishing that Section, they may be allowed to complete that Section on a different day within the approved testing window. TAs must note the exact place in the Section where the student stopped and the amount of time remaining.

Students are NOT allowed to alter any previously entered or written responses because they may have had the opportunity to review material related to the test. They must pick up exactly where they left off. To allow students taking a Make-up test to sign in to the missed Section, be sure to provide the Seal Codes for the appropriate Administration and Section in ADAM. If the STC does NOT properly move them to the next Section, students may enter the previous Section. **Students must NOT be given time to work in the previous Section of a test. This is a testing irregularity.**

In some cases, the STC may move a student into a Make-up Administration with other students from other Administrations of the same content. This will allow all students in that new Make-up Administration to have the same Seal Codes. This may make it easier to administer Make-up testing.

## 4.10 Script for Administering High School Mathematics (Geometry, Algebra I, and Algebra II) - Computer-Based Testing

Instructions for Section 1 are covered in 4.10.1. Instructions for Sections 2-4 are covered in 4.10.2.

TAs are required to adhere to the scripts provided in this manual for administering the MCAP assessment. Read word-for-word the **bold** instructions in each SAY box to students. You may NOT modify or paraphrase the wording in the SAY boxes. Some of the SAY boxes are outlined with a dashed line and should **ONLY** be read aloud if they are applicable to your students. TAs should be familiar with the specific script before administering the assessment.

It is critical to ensure that students have the appropriate accessibility features and accommodations prior to testing. Refer to Section 3.4 for further instructions on how to check accessibility features and accommodations.

TAs must make sure all testing devices are turned on and TestNav is launched to the **Sign-In** page. **If headphones are needed as an accessibility feature, make sure they are plugged in prior to launching TestNav. Headphones used as noise buffers should NOT be plugged into any device.**

**IMPORTANT:** Students in Regular Online Algebra I MUST begin with Section 1 of the assessment. Students in Algebra II, Geometry, and all Text-to-Speech or other accommodated forms should begin with Section 1 but, if necessary, the STC may move the student to a Section out of order.


#### 4.10.1 High School (Algebra I) Mathematics – Section 1

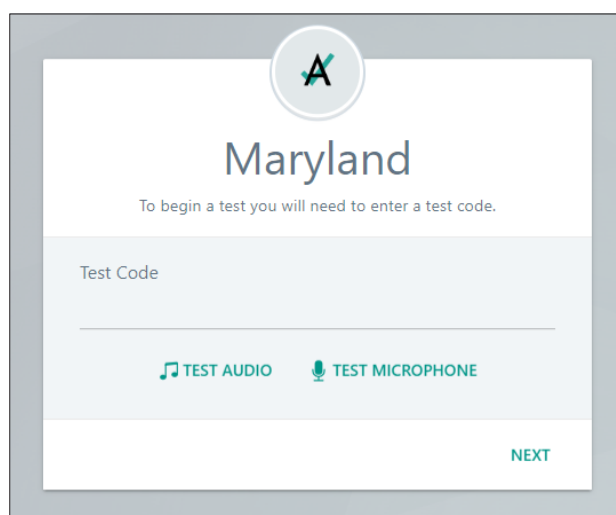

Some students may have a documented accommodation to use the calculator during the non-calculator items and may use that same calculator throughout the entire test.

If a student has the wrong Print Card, provide the correct student Print Card to the student. If you do NOT have the correct student Print Card, contact the STC.

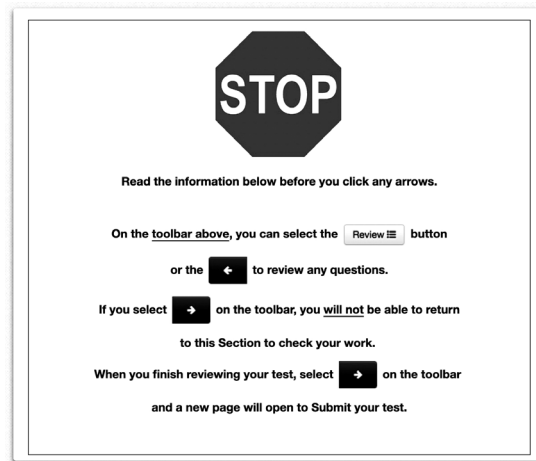

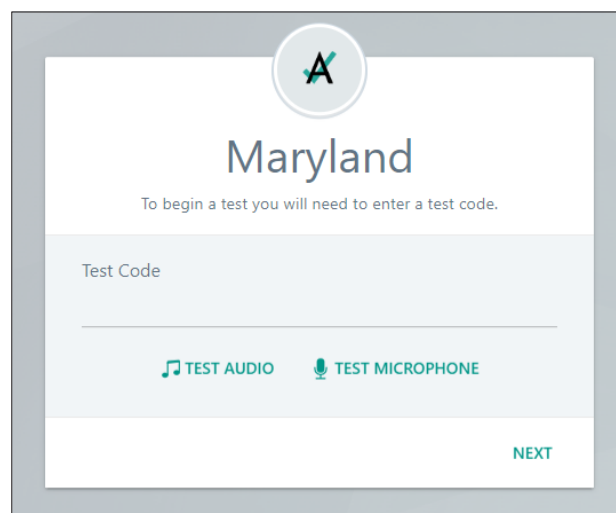

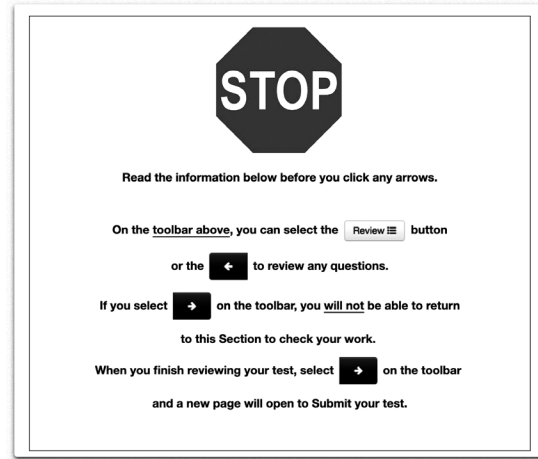
